Did You Know?

75% of first-year students received financial aid offers ranging from \$500 to \$65,000

The average financial aid offer for first-year students was **\$14,633**

Students who borrow at Rutgers University typically take out **\$21,222** in federal loans over the course of their undergraduate study

More than **\$99 million** awarded to first-year students

91% of Rutgers University–Camden students received financial aid

92% of Rutgers University–Newark students received financial aid

73% of Rutgers University–New Brunswick students received financial aid

It's Easy to Apply for Financial Aid!

FAFSA

1. Go to studentaid.gov.
2. Create a separate Federal Student Aid (FSA) ID for yourself and your parent/guardian.
3. Complete the FAFSA form and include the Rutgers Federal School Code, 002629, in Step 5.

NJAFSA

1. Go to hesaa.org/Pages/NJAlternativeApplication.aspx.
2. Complete the NJAFSA application and include the Rutgers Federal School Code, 002629, in Section H.

What Kind of Financial Aid Is Available?

Federal Aid

Grants (do not need to pay back)

- Federal Pell Grant: Need-based grant for students pursuing their first bachelor's degree
- Federal Supplemental Educational Opportunity Grant: Need-based grant for students pursuing their first bachelor's degree

Loans (must be paid back)

- Federal Direct Stafford Loans (Unsubsidized and Subsidized): Federal loans made directly to students at a fixed interest rate
- Federal Direct Parent PLUS Loan: Additional loan a parent can take out in their own name and apply to their child's education

GI Bill Education Benefits

- U.S. Department of Veterans Affairs benefits may cover some expenses for veterans, active service members, and their families

Federal Work Study Program

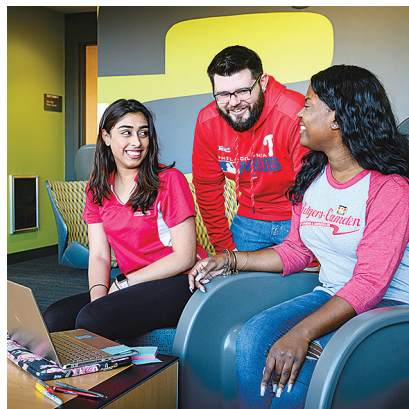
- Need-based program that pays students throughout the year to work on campus and in local communities

Grants (do not need to pay back)

- Educational Opportunity Fund: Need-based grant for New Jersey students
- Tuition Aid Grant: Need-based grant for New Jersey students

Rutgers Aid

Scholarships (no separate application and do not need to pay back)

- Merit-based: Scholarships awarded by Rutgers University to students based on merit
- Bridging the Gap, RU-N to the TOP, and Scarlet Guarantee programs build on existing state and federal aid programs to enable in-state students with family incomes below \$65,000 to attend the university tuition-free and to reduce tuition and fees for students with family incomes below \$100,000.
