*The following documents may be used as proof you live in New Jersey. This is not a comprehensive list, but categories of the most common types used by veterans and their eligible family. - A current and valid New Jersey driver license or New Jersey state identification card.
- Any other official identification card or license issued by a New Jersey governmental body or unit.
- Any identification card issued by a New Jersey employer in the normal course of business and bearing a photo of the card holder, but not including a business card.
- A real estate tax bill or receipt for the current year or the year preceding the date of enrollment.
- On campus residential housing agreement
- A gas, electric, or telephone service statement (utility bill) for the period commencing no earlier than 90 days before the date of enrollment.
- Bank statement
- Paycheck
- A check or other document issued by a unit of government.
- Residential lease that is effective on date of registration.
- An affidavit on public or private social service agency letterhead identifying a homeless veteran, their spouse or child, and describing the individual's residence for purposes of attending Rutgers.
